

Guidelines for completing Vetting Invitation Form (NVB 1)

Please read the following guidelines before completing this form.

Miscellaneous

The Form must be completed in full using **BLOCK CAPITALS** and writing must be clear and legible.

The Form should be completed in ball point pen.

All applicants will be required to provide documents to validate their identity.

The National Vetting Bureau Process

- 1. Fill out the attached form with your address and relevant contact details.
- 2. Immediately return this completed form back to Locum Express. Await your email link from the NVB which you should receive within 5-10 working days.
- 3. Once you receive the email, follow that link to complete the online vetting form, please note you have a very limited time before the link expires.
- 4. Await your Vetting Disclosure which will be sent to both you and Locum Express via email. (Should there be any queries on your application there may be a delay in your disclosure, resulting in a delay in your next employment commencement date.)

Documentation To Validate Your Identity (Scan & Email to Locum Express)

- 1. Scan of Identification document (Passport)
- 2. Scan of utility bill and/or bank statement to show proof of address.

Please submit both of the above, along with at least one of the following:

- Irish driving licence or learner permit
- Irish Public Services Card
- Irish certificate of naturalisation
- Birth certificate
- Garda National Immigration Bureau (GNIB) card
- National Identity Card for EU/EEA/Swiss citizens
